Minutes of the Annual General Meeting held on Thursday 10th June 2020 **at 20.00 hours via 'Zoom'**

Last Minutes: The Minutes of the Annual General Meeting of 11th June 2020 were approved as a true record.

Adoption of Accounts and Annual Report:
The Accounts were unanimously approved.

Election of New Clubs:

There were no new Clubs applying for membership of the league; however the meeting welcomed 3 existing Member Clubs for reentering teams – these being Berg FC, Reading United and Wrightchoice.

Constitution of the Competition for 2021/22 season:

The Meeting was informed that age groups U7 through to U14 inclusive would be constituted in 2021/22, and with Form B's having already been received from all Clubs, the League would add their structure to WGS in July once all Clubs had designated their RWBL teams on WGS during June.

Election of Officers and Management Committee:

The current elected Officers and Management Committee were re-elected, but it was noted that the position of Secretary would be held by Malcolm Hillen in the interim until such time as a permanent replacement for Harry Prestidge was appointed. Also, Dave Pearton would be standing down as soon as an Age Group Manager for the U9s & U10s could be appointed as he was being relocated with his work.

Alteration to Rules: The rules changes proposed by the Committee had been previously circulated to member Clubs by email, but were shown to the members on the Zoom call via screenshare.

An addition to the change to Rule 20 (D) was suggested by Sean Deoliveira of Barton Rovers to

include Trophy Events in the provision of WGS Team Sheets.

With this change agreed, the Meeting agreed to accept the rules changes unanimously.

Dates for the commencement and finish of the 2021/22 Season.

The season would run from the first Sunday in September to the last Sunday in April 2022. All games would be played within this window.

Date of 2022 AGM.


The date will be 9th June 2022.
